No. 956-PO/O/C-IV/1E-132/13 dated 19th December, 2018 – In continuation of the earlier Notification of this Department bearing No. 521/PO/O/C-IV/1E-132/13 dated 12th July, 2018 and in exercise of the Power Conferred by Sub-Section (2) of Section 3 of the West Bengal Right to Public Service Act, 2013 the Governor is pleased hereby to notify the services along with the stipulated time limit for rendering the services, the Designated Officers responsible for providing the services, the Appellate Officers and the Reviewing Officers as follows :-


2. In respect of services mentioned above there is already statutory provision for designated authorities upto Appellate authority in the Electricity Act 2003, WBERC Regulations and Central Electricity Authority (Measures Relating to Safety and Electric Supply) Regulations, 2010 as amended upto date. There is no provision for reviewing authority therein. If there is any amendment in those Acts & Regulations in future as to various designated authorities, or the time limit for providing services, the same will be applied **ipso facto** to the provisions in this Notification relating to the said services.

No services mentioned in this Notification will be subject to any service tax since the services provided are in the nature of statutory obligations which are to be fulfilled in accordance with the Electricity Act, 2003, WBERC Regulations and Central Electricity Authority (Measures Relating to Safety and Electric Supply) Regulations, 2010 as amended upto date and the rules & Regulations made there under.

4. This Notification is issued in cancellation of the Notification No. 772-PO/O/C-IV/1E-132/13 dated 11th October, 2017

The Notification shall come into force on the date of publication in the **Official Gazette**.
